Professional and amateur artists 18 years and older are invited to submit work.

All Mediums Accepted

All work must be original (no giclee prints),
completed within the past 36 months, and never entered into the BAYarts
Juried Show before. Artists need not reside in the State of Ohio to submit works of art.

DELIVERY

Delivery of artwork is to be made by artists to BAYarts on Friday April 6, 2018 between 9AM
and 6PM, Saturday April 7, 2018 between 9AM and 5PM, and
Sunday April 8, 2018 between 12PM and 5PM
to the Fuller House Sullivan Gallery.

Only those artists whose work has been accepted will be notified. Notification will be made late Tuesday April 10, 2018 or by
12PM Wednesday April 11, 2018. Work that has been accepted cannot be removed until after the exhibit has closed.

PICK UP

**Work that has not been accepted must be picked up on Wednesday April 11, 2018 between
12PM and 7:00PM or Thursday April 12, 2018 between 9AM and 12PM**

ENTRY FEES

An entry fee of \$30 will be collected. A Maximum of two (2) works may be submitted.

ENTRY RULES

List works submitted in the space provided below. Entries may not exceed 42 inches in width and/or length. All hanging work must be
backed, dry and wired for hanging. Any work deemed by BAYarts to be too fragile for public display or not wired sufficiently will not be
accepted. NO SAWTOOTH HOOKS. A label must be attached to the back of each piece of work. The label must contain the name of
the piece of work, the artist's name, address, telephone number, medium and price.

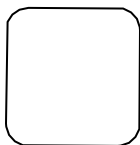
Price should include BAYarts 40% commission.

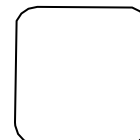
